

Direct Mailings

- Used to notify municipalities, landowners, NACCs, First Nations, MMF, and stakeholder groups
- 216 packages delivered by Canada Post
 - Letter outlining current engagement process
 - Landowner letter contained affected parcels and associated 1:50,000 scale maps
 - Localized and study area mapping
 - Regional Open Houses and/or Landowner Information Centre Schedule
 - Website and toll free information line/contact information included






Feedback – Wabowden

- General acceptance for the proposed route adjustments
 - Limits new access into areas previously undisturbed
 - AFPR follows existing infrastructure, which is seen as positive
 - Staging site/camp/storage area offered at Ponton
- General concern with access to the RoW by all terrain vehicles and snowmobiles


Feedback – GHA 14 "Moose Meadows"

- Positive and negative views on the proposed adjusted route
- Wildlife concerns exist along both proposed routes
 - Migration corridor
 - Population decline

 Presence of moose on both routes



Feedback – GHA 14 "Moose Meadows"

- Access increased for hunting and snowmobiling
- Private land concerns regarding use and increased access
- Treaty Land Entitlement Concerns (WSFN)
- Vegetation Management
- Protected Areas Steeprock Canyon



Feedback – GHA 14A/19A

- "Berry Capital" of the area
 - AFPR viewed both positively and negatively
- Moose hunting effects with the AFPR over the FPR (crown vs. private access)
- Heritage concerns east of Briggs Spur and in the Pine River Area
- Line of sight



Feedback – GHA 14A/19A

- Vegetation
 Management
- Moose hunting past success
 - Very little moose located along the FPR
 - "Better" habitat viewed as being crossed with the AFPR





General Project Commentary

- Project discussions occurred that were outside of the focus of the three route adjustments
 - East side
 - Construction
 - Training & employment opportunities
 - Electric and Magnetic Fields
 - Noise

- Slight modifications for private landownership suggested
- Avoidance of the Bison Ranch in GHA 14A/19A
